On these pages, you will find an alphabetical listing of every church in the Baltimore-Washington Conference with the percentage of Mission Share paid through the end of 2025. Last year, 74%, or 407 of the conference's 553 churches, paid 100% of their mission shares. The overall budget collection rate was **84.2%**. As a connection the Baltimore-Washington Conference contributed **\$11.8 million** to mission and ministry around the block and around the world.
